Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at the Hilton Garden Inn, located at 11460 West Hilton Way, Avondale, Arizona 85323, commencing on Wednesday, June 7, 2023, at 9:00 a.m., and will continue, as necessary, on Thursday, June 8, 2023, and Friday, June 9, 2023 at the same location beginning at 9:30 a.m., unless a tour is taken. If a tour is taken, it will begin on an alternative date and time set by the Chairman of the Committee ("Chairman").

Public comment will be taken in a special evening session on Wednesday, June 7, 2023, at 5:30 p.m. and may be taken at the beginning of each hearing day or at other times during the hearing at times designated by the Chairman. - Vote and decision concerning findings of fact, conclusions of law, the certificate of environmental compatibility and conditions to the certificate of environmental compatibility;
